- Tata Sons sold 2.34 crore shares or 0.65 percent equity in Tata Consultancy Services through a block deal for ₹9,362.3 crore (\$1.13 billion).
- India's growth expected to be between 6.5 to 7 percent n FY25.
- As per Swiss Wealth Management major UBS, India's GDP growth is expected to moderate to 7 percent in 2024-25 from the estimated 7.6 percent.
- Current account deficit (CAD) narrowed sequentially to \$10.5 billion in the quarter ended December 2023 (Q3 FY24), 1.2 percent of gross domestic product (GDP), from \$11.4 billion in Q2 FY24 (1.3 percent of GDP).
