Ghosh has over three decades of experience in the microfinance, banking and development sector. Private sector lender Bandhan Bank on October 18 reported a net profit of Rs 721.20 crore in the July-September quarter of the current financial year, up 244 per cent from Rs 209.3 crore in the same period last year. The bank's gross non-performing assets (GNPA)

increased by 14.8 percent year-on-year in the quarter under review. In absolute terms, gross NPAs stood at Rs 7,874 crore in the July-September quarter, compared to Rs 6,854 crore in the year-ago period. Gross NPA in the last quarter stood at Rs 6,961 crore.

State Bank of India (SBI) stake in Jio Payments Bank reduced from 30% to 23% in FY 2023.

Colorado has infused ₹9.48 crore into the payments bank's account from its March quarter earnings, according to India's largest lender. In FY21, Jio Bank reported a loss of Rs 89.7 crore on revenue of Rs 13.39 crore. In FY2020, it reported a profit of Rs 50.36 lakh on revenue of Rs 19.39 crore. In FY21, the Reserve Bank of India (RBI) imposed a penalty of Rs 1 crore on the payments bank for delay in applying for the reappointment of its managing director and chief executive officer. RBI's action comes under Section 35B of the Organizational Act, 1949 (Act). The payments bank was required to submit an application four months before the date of contract expiry in case of re-appointment of its MD and CEO. Updates like Permanent Bank has already applied for small finance bank license. The Reserve Bank last year notified it as a benchmark bank, allowing it to expand its network implementation.

US Firms recorded 51% share in global arms revenues in 2022

Forty-two American companies accounted for 51% of the total arms revenue of the top 100 firms in 2022 despite a 3.5% fall in revenues from sales of arms and military services compared to 2021. According to the latest Stockholm International Peace Research Institute (SIPRI) report, the 100 largest companies in the industry earned revenues totalling \$597 billion in 2022 due to production challenges and backlog and falling arms revenues among major companies in the United States. Among top 100 companies, the arms revenues of 42 American companies fell by 7.9% to \$302 billion in 2022 with 32 recording a fall in year-on-year revenue due to supply chain issues and labour shortage caused by the pandemic.

As per the assessment report for 2023, the total annual groundwater recharge for the entire country is 449.08 billion cubic meters (BCM), which shows an increase of 11.48 BCM over the previous year (2022) and the annual groundwater extraction for the entire country is 449.08 billion cubic meters (BCM). Further, out of the total 6553 assessed units in the country, 736 units have been classified as 'over-exploited'. Furthermore, the analysis indicates improvement in groundwater status in 226 assessment units in the country compared to the 2022 assessment data. Furthermore, an overall reduction in the number of overexploited units and the stage of groundwater extraction level has also been observed.

Gajraj Systems to install AI based monitoring system to prevent elephant deaths on Indian Railways tracks!

Indian Railways is preparing to deploy "Gajraj System", an artificial intelligence-based solution, on 700 km of railway tracks in forest areas to reduce elephant deaths. The purpose of this monitoring system is to alert loco pilots about the presence of elephants on the tracks. Government figures show that an average of 20 elephants die every year in train collisions in the country, with the majority of incidents occurring

in the Northeast Frontier Railway (NFR) region. According to the NFR, from its launch in December 2022 to July this year, the system issued 9,768 alerts, an average of 41 alerts per day. Whenever an elephant steps on the track, the system issues alerts to various concerned parties, including the train controller, station master, train drivers and other stakeholders, thereby taking precautionary action to prevent potential hazards. Embedded within the OFC network, the device detects vibrations caused by elephants on the tracks, sending real-time alerts to the division control room and a mobile application. It is capable of detecting and locating elephants moving within a radius of 5 meters through fiber optic cable, this system works effectively.

The world's first portable hospital 'Arogya Maitri Aid Cube' was unveiled in Gurugram.

The world's first portable hospital, 'Arogya Maitri Aid Cube' was unveiled in Gurugram on 2 December 2023. Indigenously designed under Project 'Bheeshma', the modular trauma management and support system is made up of 72 detachable mini-cubes, each with a specialized station for emergency response and humanitarian efforts. It can handle gunshot injuries, burns, head, spinal cord and chest injuries, minor surgeries, fractures and major bleeding. It can treat more than 200 patients. These cubes are lightweight and portable, and can be rapidly deployed anywhere from airdrop to ground transportation. Air Vice Marshal Tanmay Roy said the mobile hospital is part of India's message of health for all and helping other countries in times of crisis.

While total infections among girls aged 10-19 have almost halved since 2010 – from 190,000 to 98,000 – last year girls were still twice as likely to be infected with HIV as boys. Globally, there were 270,000 new HIV infections among all children and adolescents aged 0-19 in 2022, bringing the total number of youth living with HIV to 2.6 million. In sub-Saharan Africa, HIV prevalence among adolescent girls and young women aged 10–24 is three times higher than their male counterparts. Progress toward ending AIDS remains slow, with one million deaths among children aged 0–19 years globally due to AIDS-related causes in 2022. 99,000 children and adolescents are dying, which is 15 percent of all AIDS-related deaths, even though this age group comprises only 7 percent.

Passengers using Terminal 2 (T2) of Bengaluru's Kempegowda International Airport (KIA) will soon not be required to remove personal electronic devices like mobile phones and laptops from handbags at the security checkpoints before boarding. KIA operator Bengaluru International Airport Limited (BIAL) said the trial run of the CTX (computer tomography X-ray) machine at T2 will begin in the next few weeks. It will also eliminate the current process of patting down passengers after primary screening through walk-through metal detectors. T2, known as the 'Terminal in the Garden', was inaugurated by Prime Minister Narendra Modi in November 2022 with a construction cost of around Rs 5,000 crore. It began domestic operations on January 15, 2023. The Bureau of Civil Aviation Security (BCAS) had ordered all major airports handling 50 lakh passengers to install 3D CTX machines for cabin checks by the end of the year, but most operators are likely to miss the deadline.

Energy research firm Mercom India has projected rooftop solar power installations in the country to grow by 34.7 per cent year-on-year to 431 MW during July-September 2023 due to falling module prices. Rooftop solar capacity addition was more than 1.3 gigawatt (GW) in the first nine months of 2023, compared to 1.2 GW in January-September 2022. Gujarat led the way in installing rooftop solar, contributing 26.7 percent of the cumulative installations, followed by Maharashtra (13.5 percent) and Rajasthan (8.3 percent). The top 10 states accounted for about 77 per cent of the cumulative rooftop solar installations by September 2023. Between Q3 2022 and Q3 2023, Kerala recorded the highest compound growth of 15 per cent, followed by Gujarat (7.3 per cent) and Maharashtra (5.1 per cent). Redressal (SCORES) platform. Originally scheduled for execution on December 4, 2023, the new implementation deadline for linking scores with online dispute resolution platforms is now April 1, 2024. The ODR portal will facilitate enrollment of investors and market participants, allowing them to lodge complaints and upload relevant documents. It provides status updates on complaints received by ODR institutions which are service providers that handle and mediate investors' complaints. The new process aims to resolve complaints in a maximum of 60 days. Upon filing complaints through SCORES, entities including listed companies, brokers and mutual funds must resolve them within 21 calendar days. These complaints are automatically forwarded to the concerned entities for resolution, and action taken reports (ATRs) are expected to be submitted within the same period.

India's GDP growth rate is expected to slow to 7.6% in Q2FY24

The Indian economy grew 7.6 per cent during the July-September quarter of the current financial year 2023-24 (Q2FY24) and remained the world's fastest growing major economy, according to gross domestic product (GDP) data. 'Real GDP or GDP at constant (2011-12) prices is estimated to reach ₹41.74 lakh crore in Q2 2023-24, compared to ₹38.78 lakh crore in Q2 2022-23, showing a growth of 7.6 per cent. Is. Economists expect growth to slow down in the second quarter of this fiscal year compared to the previous quarter, where it recorded a strong growth of 7.8 percent. In the forecast data of the Reserve Bank of India (RBI), the GDP growth rate for the September quarter has been estimated at 6.5 percent. India's growth will give the RBI room to focus on food inflation, which it kept on hold for the fourth consecutive policy meeting in October, which it believes is uncomfortably high.
