Businesswoman Halla Tomasdottir set to become Iceland's next president.

Halla Tomasdottir, a businesswoman and investor, has won Iceland's presidential election, topping a crowded field of candidates in which the top three finishers were women, the country's national broadcast service reports. Tomasdottir, 55, was elected to the largely ceremonial post with 34.3 percent of the vote, defeating former Prime Minister Katrin Jakobsdottir, with 25.2 percent, and Halla Hrund Logadottir, with 15.5 percent, RUV said on Sunday.

Ruchira Kamboj, India's top diplomat at UN, retires after 4 decades of service.

After an illustrious career spanning over 35 years, India's Permanent Representative to the United Nations, Ruchira Kamboj, has retired, the senior diplomat said on Saturday. The first woman diplomat to occupy the prestigious position as the Ambassador of India at the UN, Kamboj – who had joined the Indian Foreign Service in 1987 – took to social media to bid goodbye.

Additionally, he held the position of Minister of Foreign Affairs from 2011 to 2019.

Claudia Sheinbaum makes history as Mexico's first woman president.

For the first time in history, Mexico has elected a woman to serve as its president. Claudia Sheinbaum—who, according to projections, bested her main opponent, Xóchitl Gálvez, by a margin of about 30%—will officially assume office in October. With upwards of 20,000 local and federal positions in play, Mexican citizens also voted for members of Congress, the governors of eight states, and the head of Mexico City's government during this election.

RBI approves Zurich Insurance's 70% acquisition of Kotak General for ₹5,560 crore.

The Reserve Bank of India (RBI) has given its nod to Zurich Insurance Company for the proposed acquisition of 70% shareholding in Kotak Mahindra General Insurance. The acquisition is valued at ₹5,560 crore. In another development, Kotak Mahindra Bank has announced a new revision of charges for several services associated with its salary and savings accounts.

NPCI International Payments Limited (NIPL) ties up with Central Bank of Peru for UPI-like payment system in Peru.

NPCI International Payments Limited (NIPL) and the Central Reserve Bank of Peru (BCRP) have announced a partnership on Wednesday to enable the deployment of a UPI-like real-time payments system in Peru. This collaboration makes Peru the first country in South America to adopt Unified Payment Interface (UPI) technology, a symbol of India's pioneering excellence in digital payments.

Punjab National Bank (PNB) to Sell 10% Stake in Canara HSBC Life Insurance via Initial Public Offering (IPO).

PNB approves divesting a 10% stake in Canara HSBC Life Insurance through IPO. Canara Bank, with a 51% stake, and HSBC, with 26%, are the major shareholders. Canara HSBC Life reported a surplus of ₹182 crore for FY 2023-24, up 15% from the previous fiscal.

Sebi issues guidelines to relax timelines for FPIs to make material event disclosures.

The market regulator has amended the Master Circular for Foreign Portfolio Investors (FPIs) to relax timelines for disclosure of material changes and events. Type 1 material changes needs to be now informed within seven days and supported documents to be provided within 30 days. Any other changes, which are classified as Type II changes, will need to be informed within 30 days with supporting documents if any.

The System for Pension Administration (RAKSHA) or SPARSH is a web-based system for processing pension claims and crediting the pension directly into the bank accounts of defence pensioners without any external intermediary.

Adani One launches 2 credit cards in partnership with ICICI Bank.

Adani Group has entered the retail finance sector with the launch of 2 credit cards in partnership with ICICI Bank and Visa. The two cards- Signature and Platinum will be offered by Adani One, the consumer app housed by Adani Digital Labs, the digital arm of Adani Enterprises Ltd.

The Reserve Bank of India (RBI) cancelled the auction of 10-year green bonds for the first time, as traders refused to pay greenium.

In a first, the Reserve Bank of India (RBI) on Friday cancelled the auction of 10-year green bonds as traders refused to pay greenium. Greenium signifies the premium investors are willing to pay for green bonds because of their sustainability impact. Diverging from the pattern of issuing green bonds in the latter half, the government plans to issue green bonds worth Rs 12,000 crore in the first half of the current financial year. The green bonds were planned to be issued in two tranches of Rs 6,000 crore each for a period of 10 years.

The Securities and Exchange Board of India(Sebi) has launched a mobile app 'Saathi 2.0' on personal finance for investors to simplify complex financial concepts. It includes financial calculators and has modules that introduce and explain KYC (know your client) procedures, mutual funds, exchange traded funds, buying and selling shares on stock exchanges and investor grievances redressal mechanism.

The ad-hoc committee would be chaired by Usha Thorat, former Deputy Governor of the Reserve Bank of India (RBI).

77th World Health assembly held in Geneva ,Switzerland.

The Seventy-seventh World Health Assembly was held in Geneva, Switzerland, on 27 May – 1 June 2024. The theme of this year's Health Assembly was: All for Health, Health for All. Every year in the last week of May, the representatives of 194 countries who are the Member States of World Health Organization (WHO) meet at Geneva in the World Health Assembly (WHA) to endorse a number of reports and adopt a number of resolutions. Considering the high prevalence of international meetings that amount to little more than discussions without subsequent action, it might be alluring to overlook the importance of the annual WHA. But that would be a mistake.

India joins U.S.'s Red Flag air and RIMPAC naval exercises.

Indian Air Force (IAF) and Indian Navy are taking part in two mega multinational war games hosted by their U.S. counterparts. The IAF has deployed Rafale fighter jets for the two-week multinational air exercise Red Flag which commenced in Alaska on May 30. On the other hand, the Indian Navy is deploying the indigenous stealth frigate INS Shivalik for Ex RIMPAC (Rim of the Pacific) scheduled to be held in Hawaii from June 25 to August 2.

Netherlands emerges as India's 3rd largest export destination in 2023-24 after Us and UAE.

The Netherlands has emerged as India's third largest export destination after the U.S. and UAE during 2023-24, even as the country's merchandise shipments dipped by over 3%, according to the Commerce Ministry data. The main commodities which registered healthy exports growth in the Netherlands include petroleum products (\$14.29 billion), electrical goods, chemicals, and pharmaceuticals in the last fiscal.

India receives highest FDI from Singapore in FY24, Mauritius second biggest investor.

India received the highest foreign direct investment (FDI) from Singapore in 2023-24 even as overseas capital inflows into the country contracted by about 3.5 per cent due to global economic uncertainties, according to the latest government data. Though FDI from Singapore has dipped by 31.55 per cent to \$11.77 billion in 2023-24, India has attracted the maximum inflows from that country, the data showed.

NSE Indices launches new electric vehicles index to spur EV ecosystem.

NSE Indices, the index services subsidiary of the National Stock Exchange of India (NSE), launched a new thematic index — Nifty EV & New Age Automotive index — on May 30, a media release said. The index aims to track the performance of companies which form a part of the electric vehicle (EV) ecosystem or are involved in the development of new age automotive vehicles or related technology, it added.

RBI projects real GDP growth at 7% in FY25.

The Reserve Bank of India (RBI), in its annual report, projected Indian economy to grow at 7 percent in the current financial year. "Real GDP growth for 2024-25 is projected at 7 per cent with risks evenly balanced," RBI said in its annual report released on May 30. Further, the report said Indian economy expanded at a robust pace in 2023-24, with real GDP growth accelerating to 7.6 per cent from 7 per cent in the previous year – the third successive year of 7 per cent or above growth.

LIC raises holding in agrochem firm PI Industries by 5%.

Life Insurance Corporation (LIC) of India said its stake in PI Industries as an institutional investor has gone past the 5% mark after it acquired 72,000 shares of the agrochemicals firm from the open market at an average cost of ₹3,558.29 each. PI Industries is a leading player in the agro-chemicals space, having strong presence in both domestic and export markets. It has state-of-the-art facilities in Gujarat having integrated process development teams with in-house engineering capabilities. The market capitalisation of the company is Rs 53,488.98 crore, LIC said in a filing.

DBS retains India GDP growth forecast at 7% for FY24-25.

Singapore-headquartered DBS Bank expects India's economic growth to stay in the 7 percent handle in the April-June 2024 quarter. Thus, foreign bank also retained its India GDP growth forecast for current fiscal at 7 per cent. High frequency indicators suggest 4QFY24 GDP growth is likely to be above 6.8% yoy, implying an upward revision to our FY24 real GDP growth forecast. Cyclical and structural factors have turned conducive for the trajectory, helped by early signs of an improvement in rural demand, and a recovery in household-led capex, which is moving in sync with the government's higher allocations towards infrastructure.

NEW \$135 MILLION UNDP AND GEF INITIATIVE WILL SUPPORT SMALL ISLAND DEVELOPING STATES TACKLE DRIVERS OF ENVIRONMENTAL DEGRADATION.

UNDP and the Global Environment Facility (GEF) launched a new \$135 million Blue and Green Islands Integrated Programme (BGI-IP) today during the Fourth International Conference on Small Island Developing States (SIDS4). This initiative aims to emphasize the crucial role of nature and expand nature-based solutions to

combat environmental degradation in three key sectors: urban development, food production, and tourism. Targeting fifteen SIDS, the program seeks to foster nature-positive changes. Managed by the UNDP and funded by the GEF and partners, this effort represents a new wave of support for SIDS as they embark on the Decade of Action from 2024 to 2034.

New ant species discovered from Siang Valley in Arunachal Pradesh called Paraparatrechina neela.

Paraparatrechina neela has been described as a small ant with a total length of less than 2mm. Its body is predominantly metallic blue, except for the antennae, mandibles, and legs. The head is subtriangular with large eyes and has a triangular mouthpart (mandible) featuring five teeth.

Over 50 percent of world's mangroves at risk of collapse climate change leading factor.

More than half of the world's mangrove ecosystems are at risk of collapse, with nearly one in five facing severe risk, according to the findings of the first global mangrove assessment. Climate change threatens one-third (33 per cent) of the mangrove ecosystems, according to the study done using the International Union for Conservation of Nature's (IUCN) Red List of Ecosystems -- a global standard for measuring the health of ecosystems. Deforestation, development, pollution and dam construction pose a serious threat to mangroves, but the risk to these ecosystems is increasing due to sea-level rise and the increased frequency of severe storms due to climate change.

This day affirms the UN's commitment to protecting the rights of children."

On 2 June 1975, approximately 100 sex workers occupied Saint-Nizier Church in Lyon, France, to express their anger about their criminalised and exploitative living conditions. They hung a banner from the steeple which read 'Our children do not want their mothers to go to jail', and launched a media campaign to broadcast their grievances to the world. Their action made national and international news headlines, started a strike that involved sex workers from all over France, and created a legacy of activism that is celebrated each year on International Sex Workers' Day.

World Bicycle Day is celebrated on 3 June.

World Bicycle Day draws attention to the benefits of using the bicycle — a simple, affordable, clean and environmentally fit sustainable means of transportation. RBI Transfers 100 Tonnes of Gold to India from UK for the 1st time since 1991.

Recently, the Reserve Bank of India (RBI) has transferred 100 tonnes of gold from its vaults in the UK to its domestic vaults in India. This is the first time since early 1991 when such a large amount of precious metal was added to India's stock Till the end of March 2024, the RBI's gold price reserve holds around 822.1 tonnes of gold, which is marked as more than in previous years. Among this 822.1 tonnes of gold, 413.8 tonnes were held overseas, particularly with the Bank of England and the Bank for International Settlements (BIS). This recent transfer is part of a broader initiative to repatriate and secure these assets domestically.

The Computational Fluid Dynamics (CFD) software "Parallel RANS Solver for Aerospace Vehicle Aero-thermo-dynamic Analysis" (PraVaHa) is developed in VSSC to simulate external and internal flows on launch vehicles, winged & nonwinged re-entry vehicles. Initial aerodynamic design studies for launch vehicles demand evaluation of a large number of configurations. The probe's successful departure from the moon means China is closer to becoming the first country to return samples from the far side of the moon, which permanently faces away from Earth. The probe, which departed the moon at 7:38 am local time (2338 GMT) successfully completed its sample collection from June 2-3. China National Space Administration (CNSA) said in a statement that Chang'e-6 "withstood the test of high temperature on the far side of the moon". Compared with its predecessor Chang'e-5, which retrieved samples from the near side of the moon, Chang'e-6 faced an additional technical challenge of operating without direct communications with ground stations on Earth, according to CNSA.

Boeing launches NASA astronauts for the first time after delays, Indian-origin astronaut Sunita Williams on board.

Boeing launched astronauts for the first time Wednesday, belatedly joining SpaceX as a second taxi service for NASA. Indian-origin NASA pilot Sunita 'Suni' Williams and fellow astronaut Butch Wilmore took off from Cape Canaveral on board the Starliner capsule. They will arrive at the International Space Station on Thursday and
