The President also appointed former high court chief justices -- justice Lingappa Narayana Swamy, justice Sanjay Yadav, justice Ritu Raj Awasthi – as judicial members. Three others Sushil Chandra, Pankaj Kumar and Ajay Tirkey were appointed as the non-judicial members.

Sea slugs live in marine habitats and are found across the planet from the shallow intertidal areas, to the deep sea, and from the polar to tropical regions. They feed on other small animals, including other species of smaller sea slugs, marine worms, as well as small fishes. It is the second species from the Indian region and the third true tropical species.
