Through the AePS facility, a bank customer can employ their Aadhaar number as an identity verification tool to access their Aadhaar-enabled bank account. This service allows for transactions such as balance enquiries, cash withdrawals. remittances through a business correspondent. For customers to take advantage of the AEPS service, several criteria must be met. Firstly, the customer's bank must participate in AEPS. Secondly, the customer's Aadhaar number must be linked to their bank account. Lastly, transactions are authenticated through biometric data. IPPB, as the acquirer bank, does not impose any limits on AePS transactions for customers of other banks. However, the issuing bank determines these limits based on customer profiles and risk management practices.

The 2024-25 growth estimate is, however, lower than 7.6 percent projected for the 2022-23 fiscal. The ADB had in December 2023 projected the Indian economy to expand 6.7 percent in the 2024-25 fiscal. Growth will be robust despite moderating in FY2024 and FY2025. For the 2025-26 fiscal, the ADB has projected India's growth at 7.2 percent. On balance, growth is forecast to slow to seven per cent in FY2024 but improve to 7.2 percent in FY2025. The ADB's growth forecast for FY25 is in line with the projections made by the Reserve Bank of India (RBI).

Public sector general insurers clocked an 8.99 percent growth in premium to Rs 90,344.49 crore, whereas their private sector counterparts witnessed a 17.53 per cent increase to Rs 1.55 trillion. Among companies, the industry leader, The New India Assurance Company, saw a 7.4 percent Y-o-Y growth in premium to Rs 37,035.19 crore. Among other major insurers, HDFC Ergo General Insurance's premium increased by 11.61 percent to Rs 18,567.56 crore, whereas United India Insurance Company's premium surged 12.51 percent to Rs 19,851.71 crore and The Oriental Insurance's premium rose 17.1 per cent Y-o-Y to Rs 18,285.82 crore in FY24.

But, reaching the WHO elimination goal by 2030 should still be achievable, if swift actions are taken now. New data from 187 countries show that the estimated number of deaths from viral hepatitis increased from 1.1 million in 2019 to 1.3 million in 2022. Of these, 83% were caused by hepatitis B, and 17% by hepatitis C. Every day, there are 3500 people dying globally due to hepatitis B and C infections.

India and Mauritius have signed a protocol to amend the double taxation avoidance agreement (DTAA), which included a principal purpose test (PPT) to decide whether a foreign investor is eligible to claim treaty benefits. Tax experts said a new article has been added to the protocol "Article 27B Entitlement to Benefits". The amended

protocol was signed on March 7 and made public now. The amendment represents a move by India to align with global efforts against treaty abuse, particularly under the BEPS Action 6 framework. This development underscores India's commitment to international tax cooperation standards while raising critical considerations for investors leveraging the India-Mauritius corridor.

Jalpura Khurja Power Transmission Limited has been formed for "Construction of 400/220 kV, 2×500 MVA GIS substation Metro Depot with associated lines and 400/220 kV, 2×500 MVA GIS substation Jalpura", an Intra-state project of Government of Uttar Pradesh. The SPV has been handed over to M/s The Tata Power Company Limited, the successful bidder.

#### India aims to produce 100 GW nuclear power by 2047.

India aims to produce 100,000 MW of nuclear power by 2047, a massive increase from the current production of over 8,000 MW. Atomic Energy Commission Chairman A K Mohanty released a report, 'Synchronising Energy Transitions Towards Possible Net Zero for India: Affordable and Clean Energy for All'. The vision document for 'Amrit Kaal' was being prepared by the Department of Atomic Energy which envisages reaching a nuclear capacity of about 100 GW by 2047. The breeder reactors would contribute 3 GW of nuclear power, while 17.6 GW would come from light water reactors built with international cooperation and another 40-45 GW would come from the pressurised heavy water reactors. If India intends to follow coal-dependent pathways, it will need to explore carbon dioxide technologies (CDRs) as well, such as bioenergy with carbon capture and storage (BECCS) and CCUS, to fully understand their long-term potential.

The satellite was launched from the Kennedy Space Center, Florida, by SpaceX Falcon 9 rocket on April 7. The satellite was assembled at TASL's facility in Karnataka. Elon Musk's SpaceX launched a total of 11 satellites in its maiden Bandwagon flight. TSAT-1A will provide high-resolution satellite images with low-latency delivery. The Indian armed forces are expected to be one of its major users. This is the first sub-metre high-resolution earth observation

## SpaceX launched the first in a new series of rideshare missions "Bandwagon-1".

SpaceX launched the first in a new series of rideshare missions "Bandwagon-1". The 11 satellites rode onboard a Falcon 9 rocket from Launch Complex 39A at NASA's Kennedy Space Center. Like the "Transporter" rideshare flights, the Falcon 9 rocket for the Bandwagon-1 mission launched with a batch of satellites, which were deployed over a period of time. However, SpaceX did not disclose the timing of the deployments as it typically does with Transporter missions.

This is part of a larger deal that includes domestic production in India. The current order is a larger one compared with the one made in 2021 - 24 launchers and 216 missiles - as part of an emergency procurement. Igla-S system that can be operated by a crew or an individual, Igla-S has been designed specifically to bring down low-flying aircraft and even can identify and neutralise air targets like drones and cruise missiles.

## NASA have signed an agreement with Japan to advance sustainable human exploration of the Moon.

As a result, Japan will design, develop, and operate a pressurized rover for crewed and uncrewed exploration on the Moon. On the other hand, NASA will provide the launch and delivery of the rover to the Moon as well as two opportunities for Japanese astronauts to travel to the lunar surface. Japan will become the first nation after the United States to land an astronaut on the moon as part of the Artemis lunar exploration campaign under an agreement between the two countries announced April 10, 2024. At an event in Washington, NASA Administrator Bill Nelson and Japanese Minister of Education, Culture, Sports, Science and Technology (MEXT) Masahito Moriyama signed an agreement regarding an additional Japanese contribution to Artemis, a pressurized lunar rover called Lunar Cruiser.
