RBI doubles minimum capital requirement to Rs 200 crore for SFBs!

The Reserve Bank of India (RBI) has raised the minimum capital requirement for small finance banks (SFBs) to Rs 200 crore and permitted Payments Bank to upgrade as SFBs. Incidentally, the net worth of all SFBs currently in operation is in excess of Rs 200 crore. Issuing the revised guidelines, the RBI said that for Primary (Urban) Co-operative Banks (UCBs) desirous of voluntarily transiting into SFBs, the initial requirement of net worth would be at Rs 100 crore, which will have to be increased to Rs 200 crore within five years from the date of commencement of business.

World Bank raises GBP 1.5 billion in 5-year sustainable development bond?

The International Bank for Reconstruction and Development (IBRD), representing the World Bank, has successfully priced a 5-year bond in Great British Pound sterling (GBP) set to mature in October 2028. The Sustainable Development Bond aims to raise GBP 1.5 billion from investors, contributing to financing sustainable development initiatives in World Bank member countries.

P Santhosh, Chief General Manager at Canara Bank, has been appointed as the Managing Director of National Asset Reconstruction Company (NARCL)!

Natarajan Sundar, a seasoned banking veteran who previously served as Deputy Managing Director at State Bank of India, is the second high-ranking official to resign from NARCL before completing the designated tenure. Last August, Karnam Sekar, the then Chairman of NARCL, also stepped down without providing a specific reason, leaving the organization amid uncertainty. Sundar had assumed the role of Managing Director on May 30, 2022, for a two-year term, similar to the tenure of his predecessor, Karnam Sekar. Both resignations occurred before completing the stipulated two-year period, raising questions about the stability and management structure of NARCL.

The WB has kept India's GDP growth forecast unchanged at 6.3% for FY 2023-24 and 6.4% for FY 2024-25 driven by robust investment and services. It will edge up to 6.5% in FY26. India is expected to maintain the fastest growth rate among the world's largest economies, but its post-pandemic recovery is expected to slow. The World Bank on Tuesday kept its FY25 economic growth projection for India unchanged at 6.4 per cent, mainly on account of strong domestic demand, rising public infrastructure spending and strong private-sector credit growth. However, it projected that the private consumption growth might taper off due to high food inflation and diminishing pent-up demand.

LIC to pick up to 10% equity stake in NHB promoted 'RMBS' entity?

Insurance behemoth Life Insurance Corporation of India (LIC) is planning to acquire up to 10 percent equity stake in a company promoted by the National Housing Bank (NHB). The Board of Directors of LIC on Monday gave their approval to the proposal to invest in the NHB promoted entity that would focus on residential mortgage-backed securities (RMBS), according to a regulatory filing by LIC with the stock exchanges.

Taiwan's weighting in the MSCI Emerging Markets Index rose to 14.2 per cent, behind leader China's at 31.2 per cent, while India's fell to the third spot with 13 per cent, according to Bloomberg-compiled data. India had overtaken Taiwan in August to claim the second spot. India has secured a 2nd rank in the MSCI Emerging Markets (EM) index by surpassing Taiwan. The first spot is grabbed by China

Bloomberg Index Services Ltd to Include India's FAR Bonds into its EM Index from September 2024?

The proposal calls for India FAR bonds to be incorporated into the Bloomberg EM Local Currency Indices in a phased manner during a five-month period beginning in September 2024. After complete inclusion, the Bloomberg Emerging Market ten percent Country Capped Index will have 10% of India's FAR bonds as a cap. Bloomberg Index Services Ltd (BISL) proposed the incorporation of India's Fully Accessible Route (FAR) bonds into its Emerging Market (EM) Local Currency Index. As per the proposal, the inclusion of Indian government bonds will be a phased implementation plan spanning over 5 months starting in September 2024.

India Ratings raises GDP growth forecast for FY'24 to 6.7% from 6.2%?

India Ratings and Research (Ind-Ra) has revised upwards its GDP growth estimate for FY24 to 6.7 per cent from 6.2 per cent earlier. The revision is led by a number of factors, including the resilience of the Indian economy (which grew 7.6 per cent yoy in 2QFY24); sustained government capex; the deleveraged balance sheet of corporates/ banking sector; prospects for a new private corporate capex cycle; and sustained momentum in business and software services exports, coupled with remittances from across the world.

Housing Minister Hardeep S Puri acknowledges contribution of DDA in ensuring inclusion of economically weaker sections in Delhi's development?

IRDAI eases norms for insurer investment in infrastructure debt funds?

The Insurance Regulatory and Development Authority of India (IRDAI) has relaxed certain norms on investment in infrastructure debt funds (IDFs) of non-banking financial companies (NBFCs) by insurance companies. Previously, insurers were permitted to invest in IDFs backed by the central government on a case-by-case basis. The regulator has done away with the requirement for case-by-case approval for IDF as a measure to encourage investments by insurers in the sector and to increase the ease of doing business.

CBRE India's report: Maharashtra Contributes Highest Share of MSMEs in India; TN & UP among top 3!

According to the report, Maharashtra, TN, and UP contributed to nearly 40% of the total MSMEsregistered in India. Maharashtra holds 38.09 lakh MSMEs, followed by Tamil Nadu (TN) with 22.32 lakhMSMEs, and UP stands out with 20.95 lakh registered MSMEs .Rajasthan with 16 lakh and Gujarat with 15.96 lakh MSMEs were the other top destinations forregistered units in India.Note: As of 8 January 2023, official data from the Ministry of MSME reveals a substantialpresence of 2.21 crore registered MSMEs, excluding Udyam Assist Portal registrations.

Coal India Ltd Enters into MoU with National Skill Development Corporation to set up Multi Skill Development Institutes under each Subsidiary?

As agreed in the MoU, one MSDI will be set up in each subsidiary with CCL, BCCL, MCL, NCL & SECL covered in the first phase, and the remaining subsidiaries in the second phase. The existing infrastructure available at CIL subsidiaries will be developed as MSDIs. The project will cover one-time capex for repurposing of existing infrastructure as MSDIs and Recurring & Project Monitoring Unit (PMU) expenses per year. This initiative underscores CIL's commitment to foster skill development and creating sustainable employment for local youth in coal-bearing areas. The project will help the youth of command areas in getting market-oriented skill training and entering into formal sector employment/entrepreneurship.

India's GDP may grow 7.3% in FY24: Govt's first advance estimates?

The National Statistical Office (NSO) has projected the Indian economy to grow at 7.3 per cent in 2023-2024 — higher than the Reserve Bank of India's estimate of 7 per cent — assuming an investment-led recovery in the world's fifth largest economy. This beats the Street estimates by a wide margin. Most economists have assumed India's gross domestic product (GDP) to grow between 6.5 per cent and 6.7 per cent during the ongoing financial year. In FY23, GDP expanded 7.2 per cent.

FAO Food Price Index drops by 13.7% in 2023!

For 2023 as a whole, the index was 13.7 per cent lower than the average value over the preceding year, with only the international sugar price index higher over the period. The FAO Cereal Price Index increased 1.5 per cent from November, as wheat, maize, rice, and barley prices all rose, partly reflecting logistical disruptions that hindered shipments from major exporting countries. For the year as a whole, the index was 15.4 per cent below the 2022 average, reflecting well-supplied global markets, although FAO's All Rice Price Index (part of the FAO Cereal Price Index) registered a 21 per cent increase, largely owing to concerns about the impact of El Niño on rice production and in the aftermath of export restrictions imposed by India.
