The country's employment growth rate stood at 6 per cent in that fiscal year, versus 3.2 per cent in the previous fiscal year, the RBI's report on measuring industry level productivity and employment showed.

Food regulator FSSAI on Saturday approved changes in nutritional information labelling on packaged food items, proposing that total salt, sugar and saturated fat should be displayed in bold letters as well as bigger font size.

### India Creates 12.5 Crore Jobs in FY14-23, Surpasses 2.9 Crore Jobs in FY04-14.

India has created 12.5 crore jobs during FY14-23, compared to only 2.9 crore during FY04-14, per a State Bank of India (SBI) study based on RBI data. Even if we exclude Agriculture, the total number of jobs created in Manufacturing and Services is at 8.9 crores during FY14-FY23 and 6.6 crores during FY04-FY14," per a report by SBI's Economic, The total employment reported by Micro, Small and Medium Enterprises (MSMEs) registered with the MSME Ministry has crossed the 20-crore mark, according to data from the Udyam registration portal.

# Union Cabinet approves India's signing of the Biodiversity Beyond National Jurisdiction (BBNJ) Agreement.

The Union Cabinet, chaired by Prime Minister Narendra Modi, has approved India to sign the Biodiversity Beyond National Jurisdiction (BBNJ) Agreement. This landmark decision marks a significant step towards the conservation and sustainable utilisation of marine biological diversity in areas beyond national jurisdiction. Often referred to as the 'High Seas', areas beyond national jurisdiction are the global common oceans open to all for internationally lawful purposes such as navigation, overflight, laying submarine cables and pipelines, etc. The Ministry of Earth Sciences will spearhead the country's implementation of the BBNJ Agreement.

### Rajasthan to become first State to adopt a road safety action plan for 10 years.

Rajasthan is set to pioneer road safety by becoming the first Indian state to implement a comprehensive 10-year action plan. Aimed at reducing accidents and fatalities, the plan includes measures such as infrastructure improvements, enhanced enforcement of traffic rules, public awareness campaigns, and emergency response systems. This initiative is expected to significantly enhance road safety standards across the state, prioritizing the well-being of commuters and residents alike.

With the tech-city reporting a spike in the number of students falling prey to cyber frauds, the department of IT, BT has collaborated with Meta to empower 10 lakh students with digital safety knowledge and augmented reality/virtual reality (AR-VR) skills by 2025. Not just students, around one lakh teachers from across the state too will be trained under the 'Digital Nagarik and AR-VR Skills Programme', that was rolled out on Thursday. "This will be the first time in the country that such a programme has been launched," said IT, BT minister Priyank Kharge.

### Indo-Russian Joint Venture Delivers 35,000 AK-203 Rifles to MoD.

Just ahead of Prime Minister Narendra Modi's visit to Russia, the Indo-Russian Rifles Private Limited (IRRPL), a joint venture between the two countries, has produced and transferred 35,000 Kalashnikov AK-203 assault rifles to the Indian Ministry of Defence, Rostec state corporation of Russia announced on July 5.

# NASA set to Launch Habitable Worlds Observatory Telescope to Find Inhabitable Planets by 2050.

NASA is further prioritizing its long-running search for life in the universe and laying the groundwork for its next flagship astrophysics mission after the Nancy Grace Roman Space Telescope (slated to launch by May 2027). This observatory would simultaneously provide powerful capabilities for transformational astrophysics discoveries, from our cosmic backyard of the solar system to the distant universe and everything in between. Currently referred to as the Habitable Worlds Observatory (HWO), this is a concept for a mission that would search for and characterize habitable planets beyond our solar system.

### IUCN Red List Updated Ibiza Wall Lizard Designated as Endangered Species.

The Ibiza wall lizard has been newly classified as "Endangered" on the updated IUCN Red List. Endemic to Spain's Ibiza island, their population is facing a serious decline, prompting conservation concerns. This designation highlights the urgent need for protective measures to safeguard their habitat and mitigate threats.

### UNESCO Unveils New World Soil Health Index at International Conference on Soils in Morocco.

UNESCO has launched the World Soil Health Index at an international conference in Morocco, aiming to evaluate global soil health. This initiative is pivotal for sustainable agriculture and environmental conservation, addressing issues like soil degradation and food security. The index will offer essential data for policymakers, researchers, and farmers to enhance soil management practices and productivity. UNESCO aims

### **UNESCO** names 11 new biospheres in 11 countries.

UNESCO has designated 11 new biosphere reserves across 11 countries, highlighting their commitment to environmental conservation and sustainable development. These reserves, spread across diverse ecosystems from mountains to coastal regions, aim to balance biodiversity conservation with sustainable use. The designation underscores global efforts to protect natural habitats and promote harmonious coexistence between humans and nature.

#### WHO Launches MeDevIS Platform for Global Medical Device Information

The World Health Organization (WHO) has launched the Medical Devices Information System (MeDevIS), an open-access online platform to streamline global access to medical technologies and devices. MeDevIS is created to assist governments, regulators and users in making informed decisions about the selection, procurement, and usage of medical devices.

### Vietnam most affordable country for expats.

Vietnam has been identified as the most affordable country for expatriates. The cost of living in Vietnam is notably low, making it highly attractive for expats. Factors contributing to this affordability include inexpensive housing, food, and daily expenses compared to other countries in the region. This makes Vietnam a preferred destination for those seeking cost-effective living without compromising on quality of life.

### Russia plans to create core of new space station by 2030.

Russia aims to establish the core of its new orbital space station by 2030, according to its space agency, Roscosmos. The agency's head, Yuri Borisov, approved the timeline, which includes launching an initial scientific and energy module in 2027 and adding three more modules by 2030, with two additional modules planned between 2031 and 2033. Previously collaborating on the International Space Station (ISS), Russia plans to exit the ISS by 2028 and focus on its own station to address scientific, technological, and national security needs.

### Reformist Pezeshkian Wins Iran Presidential Election.

United Arab Emirates (AP) — Reformist candidate Masoud Pezeshkian won Iran's runoff presidential election Saturday, besting hard-liner Saeed Jalili by promising to reach out to the West and ease enforcement on the country's mandatory headscarf law after years of sanctions and protests squeezing the Islamic Republic.Pezeshkian promised no radical changes to Iran's Shiite theocracy in his campaign and long has

## Aselsan Successfully Launches Turkey's First Homegrown Türksat-6A Communication Satellite.

Turkish defense company, has achieved a significant milestone by successfully launching Türksat-6A, Turkey's first domestically produced communication satellite. The satellite, aimed at enhancing Turkey's communication capabilities, was launched into orbit from the Guiana Space Centre in French Guiana. Türksat-6A is expected to bolster Turkey's telecommunications infrastructure and support various communication services across the country and the surrounding region.

### Keir Starmer appointed as the UK's new PM.

Labour leader Keir Starmer officially became Britain's Prime Minister after an audience with King Charles III at Buckingham Palace. Earlier, he pledged to start a period of "national renewal" in the U.K. after his opposition Labour party defeated the ruling Conservatives in the general election.British Prime Minister Rishi Sunak conceded defeat in the national election on July 5, saying the opposition Labour Party had won.
