### Securities and Exchange Board of India (SEBI) notified regulations in REITs to create a system of regulation for Small and Medium REITs (SM REITs).

Securities and Exchange Board of India (SEBI) notified regulations in REITs to create a system of regulation for Small and Medium REITs (SM REITs). Small and medium REITs (Real Estate Investment Trust) shall have the ability to create separate schemes for owning real estate through SPV (Special Purpose Vehicle). These changes are important for formalising the sector, introducing investor faith and addressing the complexity of SPV security issues. These regulations will enable several of these prop-tech platforms to migrate to the SM REIT structure, if they meet the market regulators' 'fit and proper' criteria. SEBI guidelines for SM REITs have reduced the minimum ticket size to Rs10 lakh. The minimum number of investors in an SM REIT has to be at least 200 in any scheme, all of whom should be unrelated to the investment managers, and no single investor can own more than 25% of any scheme. These new proposed regulations mandate that investment managers must have a personal net worth of a minimum Rs20 crore out of which Rs10 crore has to be a positive liquid net worth.

The scheme was available gain from August 2022 to January 2023.

# RBI has directed card issuers, which include authorised payment system providers, banks and non-banks not to enter into any arrangement or agreement with card networks that restrains them from availing the services of other card networks.

The Reserve Bank of India (RBI) has asked banks and non-banks to let their customers decide the authorised card network for the credit cards issued to them. This effectively means that credit card issuers, especially those with a large customer base, will have to enter into tie-ups with multiple card networks. The central bank observed that some arrangements currently existing between card networks and card issuers are not conducive to the availability of choice for customers. The directions under the aforementioned clause will be effective 6 months from the issue of the circular. The clause relating to choice of card networks for customers, however, is not applicable to credit card issuers whose active card base does not exceed 10 lakh. Further, the circular is not applicable to card issuers who issue credit cards on their own authorised card network.

FDI inflows stood at USD 36.74 billion during the corresponding nine months of the preceding fiscal. Inflows during the October-December quarter of the current fiscal, however, rose by 18% to USD 11.6 billion as against USD 9.83 billion during the same quarter of 2022-23. The total FDI, which includes equity inflows, reinvested earnings and other capital — declined by about 7% to USD 51.5 billion during the period under review against USD 55.27 billion in April-December 2022.
