Moreover, the equipment manufactured by BEL is part of the 'Atmanirbhar Bharat' programme.The company has also received additional orders worth ₹86.15 crore since the last disclosure on December 15, and the said orders pertain to miscellaneous spares and services.

NHAI Revolutionising Road Travel, Nationwide GPS-based toll collection to be rolled out by March 2024!

Union Minister Nitin Gadkari recently announced that the government is planning to implement new technologies, including GPS-based toll collection systems, to replace existing highway toll plazas. The initiative aims to alleviate traffic congestion and ensure motorists are charged accurately for the distance traveled on highways. The rollout of new GPS satellite-based toll collection is scheduled to commence nationwide by March next year.

SBI to sign \$165 million LoC with World Bank for rooftop solar projects!

In September, SBI said that it plans to make home loans with rooftop solar installations mandatory for residential projects funded from the bank's long-term climate action funds drawn down from multilateral agencies. The lender has outstanding forex loans of \$2.3 billion from multilateral agencies, including the World Bank, the Asian Development Bank, and KfW of Germany.

Sebi eases norms to encourage social stock exchanges and smaller REITs!

The Securities and Exchange Board of India (Sebi) has eased the norms for social stock exchanges and Real Estate Investment Trusts (REITs) to attract more participants into the arena and, at the same time, make more instruments available for trading for retail investors. The board of the capital market watchdog, which met on Saturday, approved the reduction in minimum issue size public issuance of Zero Coupon Zero Principal Instruments (ZCZP) by not-for-profit entities from the current Rs 1 crore to Rs 50 lakh.

The plan is to create a step-down subsidiary of RIL's Viacom18 that will absorb Star India via a stock swap, the report added.Reliance is expected to be the larger shareholder with at least 51 per cent, while Disney will own 49 per cent in the merged company.
