Key provisions of this circular include the following: 1. Bidding will be allowed during trading hours on T+1 day only. 2. Employees will place bids only at cut-off price of T+1 day. 3. The maximum bid amount will be ₹5 lakh. 4. Each employee is eligible for allotment of equity shares up to ₹2 lakh. 5. In case there is under-subscription in the employee portion, the unsubscribed portion may be allotted to such employees whose bid amount is over ₹2 lakh on a proportionate basis for a value in excess of ₹2 lakh subject to the total allotment to an employee not exceeding ₹5 lakh. 6. The employees are supposed to pay upfront the margin to the extent of 100 percent of the order value in cash or cash equivalents.
