RBI Unveils **PRAVAAH** Portal, Retail Direct App, And Fintech Repository For Enhanced Public Access.

The Reserve Bank of India has launched three major initiatives - the PRAVAAH portal, the Retail Direct Mobile App and a FinTech Repository - aimed at enhancing central bank and facilitating regulatory public access to the approvals and transactions. The PRAVAAH (Platform for Regulatory Application, Validation. and Authorisation) portal is a secure and centralized web-based platform for individuals and entities to apply online for various regulatory approvals from the RBI. The portal streamlines the process of seeking authorizations, licenses, or regulatory approvals by providing a single point of contact for applicants. It is expected to improve the efficiency of the RBI's regulatory approval and clearance processes.

Vietnam's rubber-stamp parliament has approved public security minister To Lam as the country's new president after a major anticorruption campaign forced his predecessor to resign. In line with the one-party state's usual procedures, the National Assembly voted unanimously on a resolution that approved 66-year-old Lam's election after a secret ballot in which he was the only candidate for the job. The vote followed his nomination by the ruling Communist Party last week.

The Reserve Bank of India has approved Pradeep Natarajan as Whole Time Director on the Board of IDFC FIRST Bank for three years. Lithuanian President Gitanas Nauseda re-elected in vote marked by Russia fears.

During the election campaign, Nauseda repeatedly stressed that his first term in office was not easy due to the Covid-19 pandemic, a migrant crisis, and the war in Ukraine. "I am closely following world events and I see that the geopolitical situation, unfortunately, will remain difficult," Nauseda said.

RBI's supervisory inspection found violations by both banks relating to their financial position as on March 31, 2022. The RBI issued notices to both banks, requesting explanation as to why penalties should not be imposed. After reviewing their responses, the RBI concluded that the banks' lapses warranted the penalties.

SEBI Mandates Social Enterprises On SSE To Submit Annual Impact Report By Oct-End For FY24.

Capital markets regulator SEBI on Monday asked social enterprises, which have registered or mobilised funds through social stock exchange, to submit an 'annual impact report' for the financial year 2023-24 to such bourse by October-end. The annual impact report to SSE captures the qualitative and quantitative aspects of the social impact generated by the social enterprise. "Social enterprises which have registered or raised funds through SSE shall be required to submit Annual Impact Report to SSE by Oct. 31, 2024 for the Financial Year 2023-24," SEBI said in a circular.

Compared to the preceding financial year of FY22, where the unclaimed deposits with both public and private sector banks stood at ₹32,934 crore, the current figure represents a noteworthy increase to ₹42,272 crore by the end of March 2023, marking a 28 percent rise.Of the total unclaimed deposits, a substantial sum of ₹36,185 crore remained with public sector banks, while ₹6,087 crore was attributed to private sector banks by the end of March 2023.

The Insurance Regulatory and Development Authority of India (IRDAI) has asked insurance companies to seek prior approval for the appointment of their Board Chairperson, effective immediately. Existing Chairperson have been given until March 31, 2026, or the end of their current terms, whichever comes first, to comply with the new regulations.

Inflation target of 4% will be met in second half of this financial year: RBI paper.

A durable alignment of the 4% inflation target may begin to appear from second half of the current fiscal, the central bank economists led by the deputy governor Michael Debabrata Patra, who is in charge of the monetary policy department at the Mint Road, have said in the latest monthly bulletin. The monetary policy committee is mandated to bring retail inflation at of 4%, with a leeway of 2 percentage point on either side. But the central bank has not been able to meet the target so far on a durable basis instead it had missed it during the pandemic. And three successive quarter of missing the target entails the governor to write to the government.

RBI Approves Dividend Of Rs 2.11 Lakh Crore To Government For FY24.

The Reserve Bank of India (RBI) board approved the transfer of Rs 2,10,874 crore as surplus to the Central Government for the accounting year 2023-24. The decision was taken at Apex Bank's 608th meeting of the Central Board of Directors. Presided over by RBI Governor Shaktikanta Das, the board reviewed the global and domestic economic scenario, including risks to the outlook. The workings of Apex Bank during the year April 2023 – March 2024 were also discussed during the meeting.

Centre extends tenure of Army Chief Gen Manoj Pande .

In a rare move, the central government on May 26 extended the tenure of Army Chief General Manoj Pande for a period of one month, just days before his scheduled superannuation. General Pande was to retire from service on May 31 after a 25-month tenure. According to the Ministry of Defence, the Appointments Committee of the Cabinet approved one month's extension in service of Gen Pande. "The Appointments Committee of Cabinet on May 26 approved the extension in service of Chief of the Army Staff General Manoj C Pande for a period of one month, beyond his normal age of superannuation (May 31), i.e. up to June 30, under Rule 16 A (4) of the Army Rules 1954," the Defence Ministry said in a statement.

The IAF landed C-130J aircraft in Eastern Sector using night vision goggles.

The IAF has for the first time landed an aircraft using night vision goggles (NGVs) in the Eastern Sector. The C-130J aircraft Super Hercules transport aircraft was brought down safely on an advanced landing ground. Experts say this development greatly boosts the IAF's ability to operate in low-light conditions and increases its strategic advantage over its enemies

The Appointments Committee of the Cabinet, headed by Prime Minister Narendra Modi, on Monday extended the tenure of Defence Research and Development Organisation (DRDO) chief Samir V Kamat by a year. According to the government order, Kamat, who was appointed to the top DRDO post on August 26, 2022, will continue in the position till May 31, 2025, following a defence ministry proposal.

Vice Admiral Gurcharan Singh takes charge as Commandant of NDA.

An alumnus of the NDA, Singh was commissioned into Indian Navy in Jul 1990. The Flag Officer has held several appointments, both afloat and ashore. As a specialist in gunnery and missiles, he has served onboard Indian Naval Ships Ranjit and Prahar. He holds the distinction of being part of the commissioning crew of three Indian constructed warships, INS Brahmaputra as gunnery officer, INS Shivalik as executive officer, and INS Kochi as commanding officer.

South Korea completes development of long-range SAM system.

The L-SAM is a part of the Korea Air and Missile Defense system, which consists of several layers of capability designed to intercept missiles from North Korea. The L-SAM can intercept missiles at an altitude of 50–60 km, and the Patriot and Cheongung II can intercept missiles at around 40 km altitude. (Janes) South Korea's Defense Acquisition Program Administration (DAPA) has completed the development of its long-range surface-to-air missile (L-SAM) system, the country's Ministry of National Defense (MND) said on 27 May.

Market capitalisation to GDP ratio scales a 15-year high of 140.2%.

The market capitalisation (mcap) of all listed companies and traded on the Bombay Stock Exchange shot up 61 percent since the end of March 2023, compared to an estimated 10 percent growth in India's Gross Domestic Product (GDP) at current prices in FY24, according to a Business Standard report. India's mcap-to-GDP ratio has hit a 15-year high of 140.2 percent, up sharply from 95.8 percent at the end of March 2023, with the total valuation of all BSE-listed companies reaching \$5 trillion or over Rs 414.46 trillion on May 21 as against India's GDP at current prices of Rs 296.6 trillion in FY24.

Disney to sell 30% Tata Play stake to Tata Group; transaction valued at \$1 billion.

Walt Disney has finalised a deal to sell its minority stake in the subscription television broadcaster Tata Play to the Tata Group, according to a report by Bloomberg. The transaction values the satellite TV provider, Tata Play, at about \$1 billion. The Tata Group took full control of the platform after buying the 29.8 per cent stake from Disney. Disney signed a binding agreement in late February to combine its India unit with billionaire Mukesh Ambani's media arm, 'Viacom 18 Media Pvt', creating an \$8.5 billion entertainment juggernaut that will have over 750 million viewers and dominate the media sector in India.

Sebi Amends Rule to Facilitate Ease of Doing Business for Companies Planning IPOs.

The promoter group entities and non-individual shareholders holding more than 5 per cent of the post-offer equity share capital can be permitted to contribute towards the shortfall in minimum promoters' contribution (MPC) without being identified as a promoter, according to a notification issued by Sebi. Companies promoted by entrepreneurs often have several rounds of funding prior to listing their equity shares on the stock exchanges. In such situations, the promoters' holding may fall short of the minimum promoter contribution i.e., 20 per cent of the post-offer equity share capital. While the current ICDR (Issue of Capital and Disclosure Requirements) rule permits certain categories of investors to contribute equity shares held by them towards the shortfall, further flexibility has been provided.

India 'sees' its third unicorn of 2024 in logistics services platform Porter.

Logistics startup Porter has become the third unicorn this year, following an internal funding round where friends and family purchased shares directly from the company's employee stock ownership plan, according to sources familiar with the matter. Moneycontrol was the first to report the news, which said 15-20 individuals bought shares worth Rs 25 crore in the company, at a valuation of above \$1 billion. Earlier this year, fintech firm Perfios and Ola's AI venture Krutrim had turned unicorns. As per Tracxn, there were 113 unicorns in India as of earlier this month.

Global carbon pricing revenues reached record USD 104 billion in 2023, milestone in climate action:WB Report

A World Bank report reveals that countries with carbon pricing mechanisms generated a record \$104 billion in revenues last year. Over half of the funds were directed towards climate and nature-related programs. Carbon pricing, implemented through carbon taxes or emissions trading systems (ETS), is critical for reducing emissions and fostering low-emission growth. Despite this achievement, the report emphasizes that current carbon taxes and emissions trading schemes remain

insufficient to meet the Paris Agreement's climate goals. Although 24% of global emissions are covered by some form of carbon pricing, less than 1% are subject to prices high enough to limit temperature increases to below 2°C.

Expansion of the global capability centre services. among and their businesses are expected to further push exports. India's total exports stood at \$778 billion in FY24.

Credit growth to slip 200 bps to 14% in FY25 on revision in risk weights, slower GDP growth: CRISIL

Bank credit growth is likely to decelerate by 200 bps to 14 percent on year this fiscal primarily because of the economy losing its sheen this fiscal, partly due to a high base, says a report. Strong economic activity and retail credit demand drove loan growth last fiscal to a robust 16 percent. This fiscal, however, growth will be tempered by the high base effect, a revision in risk weights and a slower economy.

WEF founder, executive chairman Klaus Schwab to step back from current role.

Klaus Schwab, founder and executive chairman of the World Economic Forum (WEF), will step back from his current role and become chairman of the board of trustees by next January, the organization said on Tuesday. The Geneva-based institution said in an emailed statement it was undergoing a planned "governance evolution" from a founder-managed organization to one where the president and the managing board assume full executive responsibility.

India's energy major, IndianOil, exported its first-ever parcel of the superior 100 octane premium fuel, XP100 from Jawaharlal Nehru Port Trust (JNPT) on Saturday.

This milestone of exporting XP100 to Sri Lanka symbolises IndianOil's ambition to become a global energy player, recognized not just for the scale of operations but also for the quality of products and contributions to a sustainable future.Flagging off the inaugural shipment, V. Satish Kumar, Director (Marketing), IndianOil stated "Today marks a momentous occasion as another one of our products moves out to conquer new markets in Sri Lanka. This is the third time we are taking a product offshore, showcasing our potential to send quality products from India to the world."

GDP growth to dip to a four-quarter low of 6.7% in Q4 FY2024 from 8.4% in Q3: ICRA.

ICRA has projected the year-on-year (YoY) expansion of the GDP to moderate to a four-quarter low 6.7% in Q4 FY2024 from 8.4% in Q3 FY2024. Further, the growth in the gross value added (GVA) is estimated to ease to 5.7% in Q4 FY2024 from 6.5% in Q3 FY2024, driven by the industrial (to +7.9% from +10.4%) and services (to +6.2% from+7.0%) sectors. The agricultural GVA is expected to contract for the second straight quarter in Q4 FY2024 (-0.5%),at a pace similar to Q3 (-0.8%), amid weak trends in the rabi output (barring wheat) and concerns related to yields.

SBI Research says, India's GDP growth likely to touch 8 % in financial year 2024.

The State Bank of India (SBI) yesterday released a report anticipating India's GDP growth 7.4% in the fourth quarter of the financial year 2023-24, while the overall growth could touch 8%. The report released by the SBI's Economic Research department highlights the potential impact of global economic resilience on India's growth trajectory. The report identifies a consistent growth trend across both urban and rural sectors in India. Urban economic momentum is indicated by strong performance in passenger vehicle sales, airport passenger traffic, GST collections, credit card transactions, petroleum consumption, and toll collection. On the other hand, Rural economic indicators also show a positive trend, with diesel consumption and two-wheeler sales increasing.

SEBI Introduces New Framework For Unaffected Price Determination And Market Rumour Verification.

To facilitate ease of business, and protect stock prices from volatility arising out of market rumours, the Securities and Exchanges Board of India (Sebi) has issued new guidelines in which a concept of 'unaffected price' is presented. In a circular on May 21, 2024, Sebi reiterated that listed companies must verify and respond to market rumours when stock price changes occur due to rumours.

NSE to launch 1 paisa tick size for stocks below Rs 250.

The National Stock Exchange (NSE) has introduced one Paisa tick size for all stocks below Rs 250 per share. "Exchange has informed about revision in tick size of securities price below Rs 250 in Capital Market Segment (CM Segment) of NSE. The stock futures shall have the same tick size as applicable for underlying security in CM Segment," NSE stated.

SEBI tweaks dynamic price bands for scrips in derivatives segment.

Ligdus Garvale a new spider speciee found in Karnataka.

A team of naturalists recently documented a new spider species named 'Ligdus Garvale' from Garvale, a village nestled in the Somwarpet taluk of the Kodagu district, Karnataka.Jumping spiders are the largest family of spiders, with more than 6,380 species (family Salticidae). They are known for their ability to jump and pounce upon their prey. They are very common in the tropics, but some also live in northern and even Arctic regions.

Rangelands are facing a 'silent demise', suffering losses as high as 50%.

A new report by the United Nations paints a concerning picture of the world's rangelands, with up to 50 per cent estimated to be degraded. This figure is nearly double the previous estimates that ranged from 20-35 per cent, the land outlook report on rangelands and pastoralists highlighted. Past estimates of degraded rangeland worldwide significantly understated the actual loss of rangeland health and productivity, which could be as much as 50 per cent, agreed over 60 expert contributors from over 40 countries of United Nations Convention to Combat Desertification (UNCCD) in the report. The report, Global Land Outlook Thematic Report on Rangelands and Pastoralists, was released May 21, 2024.

New Algal Species Discovered in Kerala's Western Ghats by Phycologists.

Scientists from Catholicate College's Department of Botany have found a new species of algae. This is a big step forward in our knowledge of the variety in the Western Ghats, an area of India's mountains known for its many plant and animal species. The researchers Merin Grace Jiji, Binoy T. Thomas, and Thomas V.P. found this new species of algae in the forests of the Kumbhavurutty region in the Kollam district. They have called it Oedocladium sahyadricum. The Western Ghats have unique weather and soil conditions that make it possible for a wide range of land microalgae to grow.

MoRTH announces new rules for driver's license & RTO tests from 1 June.

The Ministry of Road Transport and Highways has announced new rules and regulations effective from June 1, 2024 to streamline and simplify the process for

licence seekers. The new regulations include a simplified documentation process and the option to take driving tests at private, government-authorised driving training centres instead of the Regional Transport Office (RTOs). The new rules will also introduce stricter penalties for traffic violations. Fines for driving without a valid licence have increased, ranging from Rs 1,000 to Rs 2,000. If a minor (under 18 years) is caught driving, their parents will face legal action and a fine of Rs 25,000. In addition, the vehicle's registration certificate will be revoked, and the minor will be ineligible for a licence until they turn 25.

The National Health Claim Exchange (NHCX) one-stop-portal is likely to be launched in the next two-three months by Government.

The government is planning to launch a Unified portal that will process health insurance claims across hospitals all over the country. The new portal will use a common data collection format that will contain all the information needed by different insurance companies. It will aim to speed-up the pre-authorisation time and discharge approvals, and bring down insurance premiums in the future.

International Day to end obstetric fistula - may 23.

Obstetric fistula is a hole between the birth canal and bladder or rectum, caused by prolonged, obstructed labour without access to timely, high-quality medical treatment. It leaves women and girls leaking urine, faeces or both, and often leads to chronic medical problems, depression, social isolation and deepening poverty. Ninety percent of pregnancies involving fistula end in stillbirth. The global landscape of maternal health has seen significant strides in recent years, yet the specter of obstetric fistula persists, particularly in lower- and middle-income countries. While pregnancy and childbirth are generally safer than ever before, thousands of women still endure the devastating consequences of obstetric fistula annually. This childbirth injury, resulting from prolonged and obstructed labor, is not just a medical issue but a reflection of systemic inequalities ingrained within societies.

World Turtle Day - May 23

Every year, World Turtle Day is observed to spread awareness about the habitat and lifestyle of turtles and tortoises. This is also an occasion to ask people to understand them better and also contribute to their well-being. World Turtle Day® was begun by American Tortoise Rescue, a nonprofit organization established in 1990 for the protection of all species of tortoise and turtle. The day was created as a yearly observance to help people celebrate and protect turtles and tortoises and their disappearing habitats around the world.

PLFS records Delhi's employment rate lowest, Kerala's highest in Q4 FY24.

Kerala recorded the highest unemployment rate among the 15-29 age group in urban areas for the January-March guarter of 2024, while Delhi had the lowest joblessness rate, according to the latest Periodic Labour Force Survey (PLFS) released by the Statistics and Programme Implementation (MOSPI). Ministrv of The overall unemployment rate for the 15-29 age group was 17 per cent for the January-March period, an increase from 16.5 per cent in the previous guarter but slightly lower than the 17.3 per cent reported in the same period in 2023. For all age groups, the unemployment rate was 6.7 per cent, marginally up from 6.5 per cent in the previous quarter and slightly below the 6.8 per cent from the previous year.

EPFO created 11.4% more formal jobs in 2023-24 at 15.4 million, shows payroll data.

Formal job creation under the Employees' Provident Fund Organisation went up by 11.4% in 2023-24 to 15.4 million as against 13.85 million formal jobs created in 2022-23, shows the government data. Provisional payroll data, released by the retirement fund body on Monday, shows 1.44 million net members were added to EPFO in March, 2024 vis-a-vis 1.54 million added in February. According to the ministry of labour and employment, the March data shows 0.74 million new members were added during the month under consideration with new members joining EPFO in the 18-25 age group constituting 56.83% of the total new members added in March 2024.

Oscar-Winning Polish Composer Jan AP Kaczmarek Dies at 71.

Polish composer Jan A.P. Kaczmarek, who won a 2005 Oscar for the score of Finding Neverland, died Tuesday at 71. His death, caused by a rare neurological disorder called MSA, was announced by Poland's Music Foundation and confirmed by his wife. Kaczmarek composed music for both European and Hollywood films, including Total Eclipse (1995) and Unfaithful (2002).

Fred Roos, Oscar-Winning Producer of 'The Godfather Part II,' Dies at 89.

Fred Roos, the Oscar-winning producer of The Godfather Part II and longtime collaborator of Francis Ford Coppola, died on Saturday, just days after his and Coppola's latest film, Megalopolis, premiered at the Cannes Film Festival. Roos was 89. "Fred Roos possessed a casting instinct that was near infallible: so beautifully demonstrated in American Graffiti and The Outsiders," Coppola wrote on social media following news of Roos' passing. "He was a great lifelong friend and collaborator with, above all, a true love for movies... He was a unique talent and will certainly be missed."

Data from the PREFIRE mission will help researchers better predict how Earth's ice, seas, and weather will change in a warming world.

SpaceX Launches First Satellites For New US Spy Constellation.

SpaceX on Wednesday launched an inaugural batch of operational spy satellites it built as part of a new U.S. intelligence network designed to significantly upgrade the country's space-based surveillance powers, the first deployment of several more planned this year. The spy network was revealed in a pair of Reuters reports earlier this year showing SpaceX is building hundreds of satellites for the U.S. National Reconnaissance Office, an intelligence agency, for a vast system in orbit capable of rapidly spotting ground targets almost anywhere in the world.
